Applicants' Clarification Regarding Access Points

Dear Ms. Monroe:

This submission responds to a request for clarification from Commissioner Bailey regarding "access points" that the Applicants intend on using to access the right-of-way during construction of the Project, should a Certificate of Site and Facility be granted. As described in the Application, the Applicants will use public roads to access the right-of-way. At each intersection of a public road and the right-of-way where the Applicant intends on accessing the right-of-way, the Applicants will require an access point. *See* Pre-Filed Testimony of John Kayser, App. Ex. 14 at page 19–20.

We understand that there has been some confusion about access points displayed on the revised Alternation of Terrain and Wetland Maps submitted on August 25, 2017. The Applicants wish to clarify that since the original filing of the Application on October 19, 2015, the Applicants have not added any new access points. All access points originally depicted on the maps that accompanied the original Application have not changed.

To clarify any confusion, the Applicants submit Exhibit number 499, which is a list of all proposed access points that are identified in the Application and exactly where they are identified on the Alteration of Terrain maps. To be clear, every point on this list was identified on the maps filed with the original application. These points have not changed in any way since that filing, including with the August 25, 2017 updated maps. If the Committee wishes to condition any Certificate it may issue on this representation the Applicants would not object.
