I respectfully request to intervene in the New Hampshire Site Evaluation Committee's Docket No. 2015-06, Northern Pass High Voltage Transmission Line.

I own a home and 120 acres of land at 250 Deerfield Rd., in Allenstown, New Hampshire. The Northern Pass high voltage transmission line proposes to pass through

approximately 1000 feet of my land. This proposal affects my rights, duties, and privileges as outlined below:

1. Bear Brook State Park is the second largest state park in New Hampshire serving our largest population base in the southern region of the state. Catamount Hill is the most popular hike. I, and all visitors, will be able to see the proposed electric transmission towers on land that I own. The towers are proposed to be 30 to 40 feet higher than the existing towers. The current towers are not above the tree line and are not visible from Catamount Hill. The proposed towers will destroy the view shed and thus the quality of the natural experience to park visitors including myself. This also affects the original deed of Bear Brook State Park--to provide a natural experience to all visitors.

2. The proposed towers of the Northern Pass high voltage transmission line will undoubtedly lower the value of my land and house as it will impact the view from multiple vantage points on my land.
