

**MOTION OF THE SOCIETY  
FOR THE PROTECTION OF NEW HAMPSHIRE FORESTS  
TO EXTEND DEADLINE**

The Society for the Protection of New Hampshire Forests (the “Forest Society”), by and through its attorneys, BCM Environmental & Land Law, PLLC, requests a deadline extension as follows:

1. On June 23, 2016 the Site Evaluation Committee (“Subcommittee”) issued an Order (“Order”) granting in part the Forest Society’s request for a second round of data requests which would be about confidential information which was not available to the Forest Society at the time of the deadline to propound data requests.
2. The second set of data requests would be due on Friday July 8, 2018 pursuant to the Order. However, because the confidential information remained unavailable until yesterday the Forest Society requests this extension.
3. Applicants filed a Motion dated June 10, 2016 requesting the SEC allow parties to reach out-of-SEC agreements regarding the sharing of confidential information.
4. Applicants and the Forest Society collaborated and agreed upon the form of a confidentiality agreement, executed it, and the Applicants provided the confidential information to the Forest Society yesterday.

5. Applicants agree to extend the Forest Society's deadline to two weeks from yesterday, which would be Wednesday July 20, 2016.

6. This should allow the Forest Society sufficient time upon receipt of the information to analyze, share (pursuant to the confidentiality agreement), and determine what data requests to propound, if any.




