# JOINDER OF THE GRAFTON COUNTY COMMISSIONERS IN THE COUNSEL FOR THE PUB LIC'S MOTION TO AMEND PROCEDURAL ORDER

The Grafton County Commissioners, respectfully joins in the Motion to Amend Procedural Order filed on October 4, 2016 by the Counsel for the Public ("Motion").

The Commissioners state as follows in support:

1. The Commissioners cannot complete their pre-filed testimony in the absence of 90-100% completed construction documents from the Applicants.

2. As noted by The Group I Abutters, and in previous pleadings filed by the Commissioners, the Commissioners also lack completed plans showing the exact underground and above ground route in Grafton County. This makes it impossible to properly evaluate some of the issues (e.g. impact on the community).

3. Grafton County also lack the geotechnical core-drilling reports.

4. Grafton County also lack proof that the Applicant has a past history and proper knowledge to bury high tension cables throughout the types of land that will be impacted.

**WHEREFORE**, Grafton County, respectfully requests the Site Evaluation Committee to Note its Joinder and Extend the Deadline by which the Commissioners must file pre-filed testimony.
