JOINDER IN NEPGA'S PARTIALLY ASSENTED-TO
MOTION TO AMEND PROCEDURAL SCHEDULE**

Municipal Intervenor Groups 1 South, 2, 3 North, and 3 South¹ submit this Notice of Joinder to the New England Power Generators Association, Inc. Partially Assented-To "Motion to Amend Procedural Schedule" ("Motion").

1. NEPGA filed the Motion with the Committee on October 17, 2016, requesting, inter alia, that the Committee A) amend the procedural schedule to establish a single date on which expert testimony is due; B) amend the existing procedural schedule and extend every remaining deadline in this proceeding, including the date on which the Committee will issue its Order and Final Decision, until a date 45 days following the date the Applicants produce all of the economic data they were ordered to produce by the Presiding Officer in the September 22 Order; and C) Amend the procedural schedule to provide for additional data requests and technical sessions once the Applicants produce all of the economic data they were ordered to produce by the Presiding Officer in the September 22 Order.

2. The above-listed municipal intervenor groups now join NEPGA's Motion and request for these groups the same relief requested by NEPGA.

- A. Accept this Notice of Joinder;
- B. Grant NEPGA's Motion and extend the same relief to the municipal intervenor groups; and
