**COUNSEL FOR THE PUBLIC'S ADDENDUM TO

Counsel for the Public, by his attorneys, the Office of the Attorney General and Primmer Piper Eggleston & Cramer PC, respectfully files this addendum to his Motion for Additional Site Inspections.

1. On January 31, 2017, Counsel for the Public filed a Motion for Additional Site Inspections (the "Motion"). Pursuant to N.H. Admin. Rule Site 202.14(d), Counsel for the Public listed those parties who concurred in the Motion.


