Now come the Grafton County Commissioners, [hereinafter "Intervenor"] by and through Grafton County Attorney Lara J. Saffo, as spokesperson, and move for an order from the Site Evaluation Committee to accept the proposal for site visits, to include an additional third day as recommended by the Counsel for the Public and more particularly, states as follows:

1. The SEC asked the Counsel for the Public to set forth a proposal for two additional days of site visits.
2. Counsel for the Public solicited input and proposed a schedule. In so doing, Counsel for the Public included a proposed schedule for a third day of additional site visits, which can be scheduled sometime after May 1.
3. The Grafton County Commissioners agree with Counsel for the Public that an additional third day of site visits is important for the reasons set forth in Counsel for the Public's motion and asks the SEC to add this additional day for site visits.
4. The Grafton County Commissioners sent out a notice requesting that parties identify whether they assent, object or concur. Intervenor Eric and Margaret Jones concurred, as well as Kevin Spencer and Mark Legasse, d/b/a Lagaspence Realty, LLC.

WHEREFORE, the Intervenor seeks the following relief:

- A. Accept the proposed site visits'
- B. Add an additional third day for site visits; and
- C. Grant such other relief as the SEC deems appropriate.
