## **Background**

On February 26, 2016, the joint applicants in this matter, Northern Pass Transmission LLC and Public Service Company of New Hampshire d/b/a Eversource Energy, filed a Request for Partial Waivers Under the Newly Adopted SEC Rules (Waiver Request). Hearings on the Waiver Request were held on April 12 and May 19, 2016. On June 23, 2016, the Subcommittee considering the Application issued a written order granting in part and denying in part the Waiver Request. The Deerfield Abutter Intervenor Group filed a timely Motion for Rehearing and requested that the Subcommittee reconsider portions of the Order allowing the waiver of administrative rules pertaining to the identification and mapping of structures and wetlands.

#### Hearing on the Motion

A hearing on the Motion for Rehearing will be conducted on August 15, 2016, at 1:15 p.m. at the offices of the New Hampshire Public Utilities Commission, 21 South Fruit Street, Suite 10, Concord, New Hampshire.

During the hearing, the Subcommittee will deliberate on the Motion for Rehearing and determine whether the Motion for Rehearing should be granted or denied or if some other relief is appropriate. Testimony will not be taken and oral argument will not be heard.

# Suspension of Order

Pursuant to RSA 541:5, the Order issued on June 23, 2016, granting in part and denying in part the Applicant's Request for Partial Waivers Under the Newly Adopted SEC Rules is hereby suspended pending action by the Subcommittee on the Motion for Rehearing.
