**REVISED NOTICE OF FINAL ADJUDICATIVE HEARINGS AND NOTICE OF  
PUBLIC STATEMENT HEARING**

This notice revises the schedule for final adjudicative hearings and provides notice of a scheduled hearing for members of the public to make public statements.

**I. Final Adjudicative Hearings**

On June 14, 2017, a Notice of Additional Final Adjudicative Hearing Dates established a schedule for hearings and/or deliberations to begin each day at **9:00 a.m.** on the following dates: **August 29, 30 and 31; and September 11, 12, 13, 14, 18, 19, 21, 22, 25, 26, 28, and 29, 2017.**

Due to scheduling conflicts, it will not be possible to proceed on September 14. That date is being removed from the hearing schedule and in its place, **September 15** is added. On August 30, the adjudicative hearing will end at approximately **3:30 p.m.** to allow for an additional public statement hearing that is described in more detail below.

The adjudicative hearings are evidentiary hearings that are open to the public. At the conclusion of the evidentiary portion of the proceeding the Subcommittee may deliberate on the merits of whether to grant or deny a Certificate of Site and Facility.

**II. Public Statement Hearing**

N.H. CODE OF ADMIN. RULES Site 202.25 provides that members of the public who do not have intervenor status in the proceeding but have an interest in the subject matter will be

afforded an opportunity to state their positions. On **August 30**, from **5:00 p.m.-8:00 p.m.**, the Subcommittee will take written or oral statements from members of the public on the proposed project.


To ensure the efficient conduct of the proceedings, if you would like to present an oral statement, please send an email, no later than **August 21**, to Marissa Schuetz, Program Specialist, at [marissa.schuetz@sec.nh.gov](mailto:marissa.schuetz@sec.nh.gov). Please include the following information in your email:

Your name, your email address, and the city or town where you live;  
Your position on the proposed project (support, oppose, no position); and  
Whether you require any special accommodations or if you have any particular requests or limitations.

The Administrator will post a final roster and schedule of speakers on the Site Evaluation Committee website at: <https://www.nhsec.nh.gov/projects/2015-06/2015-06.htm> in advance of the public statement hearing. To the extent that there is time remaining, members of the public that have not signed up in advance will be provided time to speak after those that have pre-registered.

Both the adjudicative and public statement hearings will be held at 49 Donovan Street, Concord.
