Dear Friend,

It's been more than seven weeks since the New Hampshire Site Evaluation Committee held the last of its public hearings on Northern Pass. Many of you came out to voice your opposition to the project, proudly displaying your orange and telling the SEC about the devastating impact the project would have on New Hampshire.

Yielding to mounting pressure for more opportunities for the public to speak, the SEC announced on March 1 that it would schedule two additional public hearings. We waited weeks for the SEC to announce the two hearings. Finally, last week,

the committee set a date - for a single hearing. That's right: one, on **May 19 at 6:00pm at the Mountain View Resort in Whitefield.**

Northern Pass submitted its application to the SEC six months ago, and then three months later it finally gave the SEC the additional information requested on the project, all the while hearings were held on the project prematurely. It is time for the SEC to allow the public ample time to review the application in its entirety.

We need to stop the clock NOW - contact the SEC and tell them to push the [Counsel for the Public's](#) timeline for the SEC proceedings.

Continued vigilance on the state's schedule for review of the project is extremely important, as Northern Pass continues to ignore its negative impacts and drag its feet on addressing residents' concerns. This is a very critical time in our fight against Northern Pass, and the SEC needs to give the public ample time to review the project application. Contact the SEC and tell them to push the Counsel for the Public's timeline for the proceedings!
