1	Supplemental Testimony of Kristine Tardiff and Jan McClure		
2	Q.	What is the purpose of this additional prefiled direct testimony?	
3	А.	Our additional testimony is to provide further testimony on issues such as	
4	aesthetics and natural resources.		
5	Q.	Have you had an opportunity to review the Viewshed Analysis provided by	
6	the Chesapeake Conservancy?		
7	А.	Yes. The City of Concord Conservation Commission obtained a viewshed	
8	analysis from the Chesapeake Conservancy to determine the visual impacts resulting from the		
9	proposed Northern Pass Project.		
10	Q.	Why did the City of Concord Conservation Commission determine that it	
11	was important to obtain its own viewshed analysis?		
12	А.	The Conservation Commission was concerned about the validity of the	
13	Applicants' viewshed analysis. During our Conservation Commission meeting, it was noted		
14	during our review of the Applicants' viewshed analysis that their consultant Terrence J. DeWan		
15	& Associates did not use the most current and best available elevation data and did not assess the		
16	scenic impact of the transmission structures on the scenic view from our downtown and urban		
17	residential area. During our discussions, we determined that it would be most appropriate to		
18	assess the potential viewshed impacts from the proposed Northern Pass Transmission project		
19	using Lidar elevation data collected in 2011. In addition, the Commission requested the		
20	consultant assess the visual impact of the transmission corridor from downtown and its environs.		

Our staff liaison from the City of Concord, Beth Fenstermacher, worked with the Cheasapeake
 Conservancy to obtain a viewshed analysis.

Q.

Please describe your concerns relative to aesthetics.

4 A. The City of Concord Conservation Commission is concerned about the aesthetic 5 impacts of the proposed Northern Pass project. A number of properties that are managed by the 6 Conservation Commission and/or are protected with conservation easements will have visual 7 impacts due to the proposed Northern Pass project. These properties include the Carter Hill 8 Orchard, Dimond Hill Farm, the Blood Farm, Oak Hill Conservation Area, Broken 9 Group/Whispering Heights Conservation Area, Spears Park and Turtle Pond. Although some of 10 the properties are outside the three-mile study range performed by Terrence J. DeWan & 11 Associates, they are important scenic landscapes in the City of Concord. 12 One of the goals of the Open Space Master Plan is to maintain and enhance scenic views 13 and natural vistas from the City's roads and public properties where possible. The proposed 14 Northern Pass project is inconsistent with those goals because it will adversely impact scenic 15 views and natural vistas from the City's roads and public properties. One example is the view 16 from Oak Hill Conservation Area and Turtle Pond. There are photosimulations that show the 17 negative visual impact that the proposed project will have on those areas. Both Oak Hill 18 Conservation Area and Turtle Pond are important scenic resources in Concord, and are enjoyed 19 by a number of people.

20 Concord's Master Plan and zoning support the preservation of the rural areas of the City
21 and the scenic views of our rural open space zone are an important City attribute. Our Urban

1	Growth boundary has intentionally concentrated development in the City core while protecting		
2	the scenic qualities and rural character of the less developed Open Space Residential District		
3	("RO") zone of the City. The ridgeline where the Northern Pass corridor is proposed is an iconic		
4	landmark in Concord and is a treasured view from the downtown core and many of the		
5	residential structures rising west of the downtown. Concord has recently invested several million		
6	dollars in upgrading its downtown and the views from this area to the west are ever more		
7	important to protect. The Conservation Commission is concerned about these scenic views from		
8	our urban center and many other areas where the project will be viewable. The Northern Pass		
9	structures on the eastern landscape of the City would be in direct conflict with established scenic,		
10	rural qualities City policy and conservation efforts have strived to maintain.		
11	Q.	In addition to the concerns raised in your pre-filed testimony on November	
12	15, 2016, please describe any additional concerns relative to natural resources that you		
13	would like to address.		
14	А.	As already discussed, we are concerned about the potential impact to the habitat	
15	of the Karner Blue butterflies and wetlands. The City of Concord has retained an expert to		
16	address issues relative to long term impacts of "temporary wetland impacts," as well as to		
17	discuss the fragmentation of wildlife habitat. This testimony is being submitted on December		
18	30, 2016.		
19	Q.	Does this end your testimony?
