Our beautiful "viewsheds" are a major reason for people to visit the state and the Newfound area and these will be destroyed by tower structures up to 155 feet high and rights of way up to 410 feet wide.

We already compete with neighboring states for our tourist dollars - should this project be built it will provide a reason for tourists to choose Vermont or Maine over New Hampshire. Even if potential visitors choose New Hampshire for a visit, they are more likely to choose a neighboring town without transmission towers as their destination driving business away from Bristol.

TOWN OF BRISTOL NEW HAMPSHIRE DISORDERLY ACTIONS ORDINANCE Adopted 5/22/08 Revised and Adopted 6-26-08

I. POLICY STATEMENT

It is declared to be the intent of the Town of Bristol to promote an environment free from excessive noise which unnecessarily jeopardizes the health and welfare of the citizens of the Bristol and degrades the quality of life in this community, without unduly prohibiting, limiting or otherwise regulating the function to certain noise-producing equipment which is not amenable to such controls yet is essential to the economy and quality of life of the community. The purpose of this Section is to establish standards for the control of noise and noise disturbances in the Town by prohibiting specific activities during designated times and by setting maximum permissible sound levels within the Town.

In accordance with the foregoing statement of intent, it shall be unlawful for any person to make, continue, or cause to be made or continued, any excessive, unnecessarily loud noise, or any noise which annoys, disturbs, injures, or endangers the comfort, repose, health, peace or safety of others within the Town as follows:

II. DEFINITIONS

For the purposes of this Section, the following words and phrases shall have the meanings respectively ascribed to them by this Section:

Intra-Property Real Property Division: shall mean the ceilings, walls, floors, doors and windows of any duplex, multi-family or condominium dwelling or structure which separate the real property leased or owned by one person from that owned or leased by another person.

Lawful Order: 1. a command issued to any person for the purpose of preventing said person from committing any offense when the officer has reasonable grounds to believe that said person is engaged in a course of conduct which makes his commission of such an offense imminent; or 2. a command issued to any person to stop him/her from continuing to commit any offense when the officer has reasonable ground to believe that said person is presently engaged in conduct which constitutes any such offense.

Person: any individual, association, partnership, or corporation, and including any officer, employee, department, agency or instrumentality of a state or any political subdivision of a state.

Public Right-of-Way: any street, avenue, boulevard, highway, sidewalk or alley or similar place, which is owned or controlled by a governmental entity.

Public Place: any place to which the public or a substantial group has access. The term Includes, but is not limited to, public ways, sidewalks, schools, and the lobbies or hallways of apartment buildings, hotels or motels.

Public Space: any real property or structure thereon which is owned or controlled by a governmental entity.

Real Property Boundary: any imaginary line along the ground surface, and its vertical

extension, which separates the real property owned by one person from that owned by another person.

Noise Disturbance: any noise created or allowed to continue, cause or allow to continue a breach of the peace, public inconvenience, annoyance, or alarm, by making loud or unreasonable noises in a private place or public place

which could be heard in a public place or other private places which would disturb a person of average sensibilities.

III. DISORDERLY ACTIONS

- A. A person is guilty of disorderly actions if"
 - He knowingly or purposely creates a condition which is hazardous to himself or another in a public place by any action which serves no legitimate purpose; or
 - 2. He/She:

a. Engages in fighting or violent, tumultuous or threatening behavior in a public place; or

b. Directs at another person in a public place obscene, derisive or offensive words which are likely to provoke a violent reaction on the part of any ordinary person; or

c. Obstructs vehicular or pedestrian traffic on any public street or sidewalk or the entrance to any public building; or

d. Engages in conduct in a public place which substantially interferes with a criminal investigation, a firefighting operation to which RSA 154:17 is applicable, the provision of emergency medical treatment, or the provision of other services when traffic or pedestrian management is required: or e. Knowingly refuses to comply with a lawful order of a peace officer to move from any public place;

3. He purposesly causes a breach of the peace, public inconvenience, annoyance or alarm, or recklessly creates thereof, by:

a. Making loud or unreasonable noises in a public place, or making loud or unreasonable noises in a private place which can be heard in a public place, or other private places, which would disturb a person of average sensibilities; to include but not limited to any of the following:

(1) the use, playing or operation of any radio, television, phonograph, stereo, drum, musical instrument, sound amplified or similar device which amplifies sound; or

(2) the use or display of fireworks

b. Disrupting the orderly conduct of business in any public or private facility; or

c. Disrupting any lawful assembly or meeting of persons without lawful authority.

d. operating or permitting the operation or use of any electronically amplified sound system while operating a moving or in control of a parked motor vehicle so as to produce sound that is clearly audible in a public right-of-way or public space more than fifty (50) feet from the motor vehicle, except as otherwise authorized.

e. Operating any motor vehicle so as to make any loud, unusual, or

unnecessary noise occasioned by any one or more of the following actions:

(1) Misuse of power – exceeding tire traction limits in acceleration, sometimes known as "laying rubber" or "peeling rubber", or excessive acceleration where there is no emergency;

(2) Misuse of braking power – exceeding tire traction limits in deceleration where there is no emergency.

(3) Rapid acceleration by means of quick up-shifting of transmission gears with either clutch or manual transmission or automatic transmission.
(4) Rapid deceleration by means of quick downshifting of transmission gears with either clutch or manual transmission or automatic transmission.
(5) Racing of engines by manipulation of the accelerator, gas pedal, carburetor, or gear selection whether the vehicle is in motion or stationary.
(6) Misuse of air brakes of "jake-brakes".

4. Noise Disturbance Time Restriction Prohibitions

It shall be unlawful to cause a noise disturbance as defined herein.

a. Between the hours of 10:00 PM and 6:00 AM - created by:

(1) loading, unloading, opening, closing, or otherwise handling boxes, crates, containers, building material, trash -cans, dumpsters or similar objects.

(2) The operation or use of agricultural equipment to include, but not limited to tedders, bailers and tractors.

b. Between 10:00 P.M. and 7:00 A.M. (Monday through Saturday) and 10:00 P.M. and 8:00 A.M. (Sunday) - created by:

(1) The operation, idling, or use of construction vehicles to include, but not limited to bulldozers, graders, dump trucks, backhoes, earth moving equipment, front end loaders and log skidders on the job site,

(2) The operation or use of tools, machinery, or construction equipment to include but not limited to, cement mixers, hammers, staple or nail guns, power tools (i.e. saws, drills, grinders, sanders), chainsaws, lawnmowers, electric hedger trimmers, lawn-edgers and jack hammers.

c. Permitted Firework displays are allowed until 11:00 P.M with the following exceptions; On Halloween, the Fourth of July and on New Years Eve the permitted time is extended until 12:30 A.M.

5. Exemptions:

The following uses and activities shall be exempt from noise level regulations:

a. Noise of safety signals, warning devices and emergency pressure relief valves.

b. Noises resulting from any authorized vehicle, when responding to an emergency call or acting in time of emergency, training exercises and maintenance.

c. Noises resulting from emergency maintenance work as performed by the \ Town, State or public utility companies, to include snow removal operations.

d. Municipal maintenance work where the abutters to the work site have been given prior notice of the project.

e. Any other noise resulting from activities of a temporary duration permitted

by law or for which a license or permit therefore has been granted by the Town which specifically references a temporary exemption from part or all of the ordinance.

f. Snow blowers and other types of private or commercial snow removal operations.

g. Parades and public gatherings for which the Town has issued a permit.

h. Bells, chimes or carillons, while being used for religious purposes, or in conjunction with religious services, and those bells, chimes or carillons that are presently installed and in use for any other purpose.

i. The un-amplified human voice, except where otherwise prohibited by the provisions of this Section.

6. Disorderly Actions is a violation, punishable by a fine up to \$300 for a first offense and \$600 for any subsequent offenses.

IV. TEMPORARY SPECIAL PERMIT

The Police Chief or his/her designee is hereby authorized to issue special permits for periods not exceeding thirty (30) days to persons wishing to exceed those limits provided for herein, based upon a demonstration as follows:

1. Activity sought to be engaged in is in furtherance of a substantial public interest or benefit and will not be inconsistent with the statement of purpose.

2. Activity sought to be engaged in is necessary in order to avoid undue hardship and will not be inconsistent with the statement of purpose.

V. SEVERABILITY

If any provisions of this Section or the application of such provisions to any person or circumstances shall be held invalid, the validity of the remainder of this Section and applicability of such provisions to other persons or circumstances shall not be affected thereby.
