I appreciate the concern you have expressed in the past that New Hampshire citizens have an opportunity to participate in "the process" concerning the proposed Northeast Energy Direct pipeline.

The Site Evaluation Committee (SEC) is seeking comments on rules adopted but not yet certified from a wide variety of stakeholders. I believe the request was not posted on the SEC website until February 11, 2016, but its existence was not widely known until some days later. **The commenting deadline is 2/29/2016**.

Some of us have been involved in this project for a little over a year. We are not technical experts. We have done online research, attended seminars, and searched out individuals and organizations who are technically knowledgeable in air quality, water quality, health risks, and the economics surrounding a project of this nature and scale.

There is simply not enough time for citizens to adequately review the list of proposed regulations, and either educate ourselves on their adequacy or reach out to those qualified to comment, who are willing and have the time to devote to reviewing the proposed rules and generating a constructive response.

In some areas there has not been sufficient long-term research to adequately address the issues, but much of the data acquired so far indicates the existing regulatory limits of exposure to emissions from compressor stations and other supporting infrastructure **are not adequate** to protect nearby resident.

Considering what is at stake here, I believe that rushing to advance construction of this project would be irresponsible. Please ask the SEC to extend the deadline to allow for thorough review and meaningful public input.

6. (a) Summary of the subject matter, or summary of the rule if drafted, and the effect on those regulated:

Chapter 264, Laws of N.H. 2015, codified as RSA 162-H:10-b, II, effective July 20, 2015, requires the Site Evaluation Committee to adopt rules relative to the siting of high pressure gas pipelines. Many of the rules that would affect the siting of high pressure gas pipelines were the subject of a 22-month rulemaking process that ended in December 2015.

In February 2014, the Site Evaluation Committee opened a docket and commenced a rulemaking process that resulted in extensive amendments to Chapters Site 100-300. The process afforded the public and interested parties opportunities to submit comments and attend hearings on multiple occasions. At the end of that extensive process, the Site Evaluation Committee readopted with amendment Site 100-300, effective December 16, 2015.

The Administrator of the Committee has reviewed the recently adopted rules and determined that there are areas specified in RSA 162-H:10-b, II, that are not fully addressed.

In particular, the Committee is seeking input on specific rules language to adopt, amend, or readopt with amendments, Site 300, regarding the following provisions related to the siting of high pressure gas pipelines: appropriate setbacks to mitigate potential health and safety impacts; pipeline decommissioning plan requirements; specific criteria to maintain property owners' ability to use and enjoy their property; project-related sound and vibration impact assessments; and application requirements to ensure quality construction that minimizes safety issues.

In addition, on December 15, 2015, the Committee voted unanimously to grant the rulemaking petition received from the Joint Legislative Committee on Administrative Rules to adopt more comprehensive rules in Site 302, relative to criteria and procedures for the suspension and revocation of certificates. The Committee is also seeking input to address the issues specified in this rulemaking petition.

The Committee seeks input in the form of proposed specific rules language from a diverse group of stakeholders, including project developers, environmental advocates, regional organizations, municipal governments, and citizens groups. This input is expected to be helpful to the Committee in developing an initial proposal. Submissions by electronic mail are strongly preferred.

6. (b) Brief description of the groups affected:

The rules regarding natural gas pipelines will affect applicants for Site Evaluation Committee approval of such pipelines. Those rules will also affect interveners and other public participants in matters related to proposed natural gas pipelines, including host municipalities, abutting landowners, and other local and regional stakeholders. The rules regarding suspension and revocation affect all projects within the jurisdiction of the Site Evaluation Committee.
