On November 7, 2017, the Attorney Discipline Office (ADO) filed a certified copy of documents in State of New Hampshire v. Paul Bennett, showing that the respondent, Attorney Paul J. Bennett, had pleaded guilty and was convicted of two charges of sale of a controlled drug and one charge of common nuisance. All three crimes are class B felonies.

The crime of sales of a controlled drug and the crime of common nuisance are each considered a "serious crime," as that term is defined in Supreme Court Rule 37(9)(b). Subparagraph 9(d) of the rule provides that "[u]pon the receipt of a certificate of conviction of an attorney for a 'serious crime,' the court may, and shall if suspension has been ordered pursuant to subsection (a) above, institute a formal disciplinary proceeding by issuing an order to the attorney to show cause why the attorney should not be disbarred as result of the conviction.

In accordance with this rule, on December 1, 2017, and again on December 13, 2017, the court issued an order requiring the respondent to show cause why he should not be disbarred as a result of the conviction. The respondent filed no response to the order.

NHT is requesting that the Committee issue a declaratory ruling on an expedited basis stating that the Petitioner's proposed upgrade to portions of a transmission substation in Seabrook, New Hampshire, does not constitute a sizeable addition or change to an existing facility within the meaning of RSA 162-H:5, I. On May 17, 2018, an order was issued appointing a sub-committee in this docket. See RSA 162-H:4-a, III.

NHT is a public utility in the State of New Hampshire for the purpose of owning and operating a transmission substation in Seabrook, New Hampshire. The Petitioner, in conjunction with ISO New England, has concluded that replacement of existing and aging infrastructure and components at the substation is needed to ensure the efficient and reliable operation of the New England power grid. Specifically, NHT is proposing to make the following upgrades at the substation: replace four circuit breakers with newer, more compact and efficient breakers; replace the existing foundations and support structures for three transmission lines that will involve the construction of new concrete footings; replace relay protection systems; and enhance the Air Termination Yard. The estimated cost of the proposed upgrade is \$77 million dollars.

of the White House after spoke from the South Law of the White House after seeing off a senior Kim deputy who spent more than an hour with him in the Oval Office. Much had been made of a letter his visitor was bringing from the North Korean leader, but Trump's comments left it unclear when he had even managed to take a look at it. The president said it was likely that more than a single meeting would be necessary to bring about his goal of denuclearizing the Korean Peninsula. He said, "It think you're going to have a very positive result in the end, not from one meeting." In the latest sign of hostility cooling down but hopes kept incheek, Trump sadihe had unilaterally put a hold on hundreds of new sanctions against the North, without Kim's government even asking. "I'm not going to put them on until such time as the talks break down," he said.

Parkland seniors balance grief, activism

a gunman killed 17 people at

was slogging through his final

small part to protect troops
fighting overseas, he said.
But now bullets were tearing
through his own suburban
Florida school.
As they prepare to graduate on Sunday, the Parkland
seniors are grieving from the
loss of friends while navigating tough decisions about the

future. For many seniors, the months since the shooting have been a blur of funerals, marches, voter-turnout events, television interviews and brushes with celebrities. Amid all that, the seniors also must decide: Should they go to college, enter the military or make a career of the anti-gun activism that's already shaping Florida policy and driving

a national conversation? Today Grady spends the bulk of his time as an advocate. He is part a group of students

who organized the March for Our Lives in Washington, and he's helping shape the direction of that group's movement. He's struggled with whether to withdraw his Army enlistment.

"I made a commitment to this country that I take seriously, but how can I commit toprotect people abroad when they're getting shot in their classrooms at home?" Grady

For others, a college path is a way to honor their fallen friends by forging on with plans made before the

with plans made before the shooting.
Senior Tyra Hemans got her acceptance letter from Pace University in New York the same day her flends were killed. The 19-year-old was tight with shooting victims Joaquin "Guac" Oliver and Meadow Pollack.

Her college acceptance should have been marked by jumps for joy and hugs from her mother. Instead, Hemans

felt numb.
But she decided to go, realizing that college and many milestones of her life will be

milestones of her life will be tinged with loss.

"When I go to college, it's going to be for Guac and Meadow, and when I walk the (graduation) stage, I'm walking for them. When I get my first job, that's Guac's first job, That's Meadow's first job, That's Meadow's first job, Twald Hemans, who want is to shyth business manwants to study business man-agement and become a sports

agent.
Eighteen-year-old
Samantha Fuentes is recovering from bullet wounds in
both legs and just had shrapnel removed from behind her nel removed from behind her right eye. After the shooting, she finished her senior year with online classes instead of returning to school, but she said she still planned to start college in the fall and move out of her mom's house. Her physical wounds are mirrored by internal changes. She stopped working at a

chocolate shop because the place felt too small to her, too tight to escape.
"I'm not afraid of going back to school. I'm not afraid of schools. I don't think you should be," Fuentes said. "I think you should be afraid of other things — a lack of change, a lack of progress."

Her nerves were on display at the March for Our Lives in at the March for Our Lives in Washington, when she vom-ited on stage in the middle of a speech before thou-sands of people. Last week, as she received a Freedom of Expression Courage Award at the PEN American gala in New York, she became tear-ful and nauseated. She fled the podium, then returned a few minutes later to a standing

minutes later to a standing ovation.

For some students, the success of their activism has proved too loud a call to ignore. Like Grady, many are changing plans made before the shooting.
