- 2 Q. Please state your name and business address.
- 3 A. My name is Joseph M. Balzano. My business address is 700 Universe Boulevard,
- 4 Juno Beach, Florida 33408.

- 5 Q. Who is your current employer and what position do you hold?
- 6 A. I am Assistant Treasurer of NextEra Energy, Inc. ("NextEra"). I also serve as
- 7 Assistant Treasurer of Florida Power & Light Company ("FPL"), Gulf Power Company
- 8 ("Gulf Power") and NextEra Energy Capital Holdings, Inc. ("NEECH"); FPL, Gulf
- 9 Power, and NEECH are wholly owned subsidiaries of NextEra.
- 10 Q. Have you testified previously in this docket?
- 11 A. Yes. On October 18, 2019, I submitted pre-filed direct testimony which provided
- 12 the Committee with a description of the financing plans sufficient to construct and
- decommission the Project and an overview of the financing plans between NEECH and
- 14 Chinook Solar, LLC. My pre-filed direct testimony indicated that prior to construction
- 15 Chinook Solar would post a Financial Assurance Mechanism ("FAM") to cover the

- 1 estimated cost of decommissioning the Project. At that time I indicated that the FAM
- 2 would be in the form of an irrevocable standby letter of credit, performance bond, or
- 3 surety bond in the amount of \$900,432.
- 4 Q. Since you filed your direct testimony in this docket is there any additional
- 5 information relevant to your direct pre-filed testimony that you want to bring to the
- 6 Committee's attention?
- 7 A. Yes. It is my understanding that the Town of Fitzwilliam would prefer that the
- 8 form of the FAM be a surety bond. Chinook Solar agrees with having the form of the
- 9 FAM be a surety bond in the amount of \$900,432. I would therefore like to modify my
- 10 pre-filed direct testimony accordingly.
- 11 Q. Does this conclude your supplemental testimony?
- 12 A. Yes.
