## NOTICE OF SITE VISIT

I hereby expressly waive and release any and all claims in any jurisdiction against TransAlta, and its officers, directors, employees, agents, affiliates, successors, and assigns, on account of injury, death, or property damage arising out of or attributable to my participation in the site visit, whether arising out of the negligence of TransAlta or otherwise.

This Agreement constitutes the sole and entire agreement between TransAlta and me with respect to the subject matter contained herein. This Agreement is binding on and shall inure to the benefit of TransAlta and me and their respective successors and assigns. All matters arising out of or relating to this Agreement shall be governed by the laws of the State of New Hampshire.
