**NOTICE OF PUBLIC MEETING
TO BE HELD ON JULY 21, 2021 AT 1:30 P.M. AND AGENDA**

PLEASE TAKE NOTICE that the full Site Evaluation Committee (“Committee”) has rescheduled its public meeting previously scheduled for June 23, 2021. The Committee will hold a public meeting on **July 21, 2021, at 1:30 p.m.**

With the expiration of the State of Emergency, the Committee must fully comply with all requirements of RSA chapter 91-A, including the requirement that a quorum of a public body must be physically present at the location specified as the location of the public meeting in the meeting notice. Therefore, the Committee will meet **in-person** at the offices of the New Hampshire Public Utilities Commission, 21 South Fruit Street, Suite 10, Hearing Room A, Concord, New Hampshire. However, the Committee is aware that not all members of the public have returned to in-person environments and that some prefer remote participation. Therefore, the Committee intends to provide a hybrid approach to accommodate those who are remote and those who are physically present. A quorum of the Committee will be physically present within a hearing room for all Committee meetings.
